For whom is this notice?

This notice is addressed to journalists, content creators, and influencers who use our Press Center.

From where do we have your data?

We collected it through the registration form.

What data do we process?

First name and last name, country, mailing address, electronic mail address, telephone number, medium/channel you represent, position, username (Twitter), username (Instagram), username (YouTube), username (Twitch).

How do we use your data?

Do you have to give us data?

You do not have to give us data; however, if we do not get it we will not be able to enable you to use Press Center. The failure to provide us with data needed to send marketing materials will not affect the opportunity to open a Press Center account.

Your rights

Right	When you can exercise it	
to access data	in any situation	
to rectify data	where the data is incorrect or incomplete	
to erase data	 if we no longer need the data to achieve the purposes for which we collected it if you withdraw the consent based on which the data is processed if you object to the processing of data if we processed data in contravention of the law if we should delete data in order to perform our legal obligation 	
to restrict processing	 if data is incorrect – for a period enabling us to verify its correctness if data was processed in contravention of the law but you do not wish to have it deleted if we do not need your data but you may need it to assert or defend claims if you object to the processing of data – until it is determined whether our interest is superior to the grounds of your objection 	
to transfer data	if the processing is based on consent or on a contract executed with us and it is automated	
to object	if we process your data based on a legitimate interest, and the objection is justified by your specific situation	
to lodge a complaint	you can always lodge a complaint with the President of the Personal Data Protection Authority (<i>PUODO</i>) or with your country's local data protection authority	

Data recipients

We can make your data available to partners who support us in different processes connected with the entire lifetime of the contract:

- · electronic signature operators who assist us in concluding contracts
- entities providing us with project management and content sharing tools
- auditors, actuaries, law firms, law and tax firms providing us with services

Whenever obliged to do so, we will make your personal data available to applicable courts and/or public administration authorities.

Transferring data outside EEA

Your data may be processed, retained or transferred to our partners having their registered offices outside the European Economic Area. We ensure the security of your data by transferring it to countries that provide security at an appropriate level or by applying EU standard contractual clauses.

Automated processing and profiling

We will not use automated decision-making process, including profiling, based on your data. By profiling, we mean drawing conclusions based on the data collected about you, for example about your present or future preferences or interests.
