### Your rights

Right	When you can exercise it

to erase	• where we no longer need the data in order to achieve the purposes for which we collected it

	where you object to data processing	
	<ul> <li>where we processed the data in contravention of the law</li> </ul>	
	<ul> <li>where we should delete the data in order to perform our legal obligation</li> </ul>	
to restrict processing	<ul> <li>where the data is incorrect – for a period enabling us to check its correctness</li> </ul>	
	<ul> <li>where the data was processed in contravention of the law but you do not wish to have it deleted</li> </ul>	
	<ul> <li>where we do not need your data but you may need it to assert or defend claims</li> </ul>	
	<ul> <li>where you object to the processing of data – until it is determined whether our interest is superior to your objection grounds</li> </ul>	
to transfer data	where data processing is based on consent or on a contract executed by us and it is automated	
to object	where we process your data based on a legitimate interest, and the objection is justified by your specific situation
